**SECTION 21 OF THE FIREARMS ACT 1968 States that anybody sentenced to Imprisonment, Youth Custody or Detention in a Young Offenders Institute for three months or more but less than three years is prohibited for FIVE years from the date of their release from possessing a Firearm or Ammunition . Anybody sentenced to more than THREE years is prohibited for life from possessing a Firearm or Ammunition.**

**It is an offence for a person to transfer, let on hire, give or lend a Firearm or Ammunition to someone whom He/She knows or has reasonable grounds for believing to be prohibited by section 21.**
